AN ORDINANCE AMENDING TITLE III TRAFFIC CODE CHAPTER 380 SCHEDULE III AND REQUIRING ALL TRAFFIC TO STOP AT THE INTERSECTION OF WATERS STREET AND KINGSHIGWAY AND DESIGNATED AS A THREE-WAY STOP; PROVIDING FOR PENALTY FOR VIOLATION THEREOF AND SETTING EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF NEW MADRID, MISSOURI, AS FOLLOWS:

SECTION I: That all vehicles traveling on Waters Street come to a stop at the intersection of Kingshighway and all vehicles traveling on Kingshighway come to a stop at the intersection of Waters Street and that said intersection shall be designated as a Three-Way Stop and that no vehicle shall proceed through said intersection until it has come to a complete stop and all vehicles proceeding through the intersection have been allowed to go through.

SECTION II: That all persons violating the provisions of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be fined a sum of not less than one dollar (\$1.00) nor more than one hundred dollars (\$100.00) or by imprisonment for a term of not more than thirty (30) days or by both said fine and imprisonment.

SECTION III: That this Ordinance shall be in full force and effect ten (10) days after its passage and approval and all Ordinances in conflict herewith are, insofar as they conflict, hereby repealed.

AN ORDINANCE AMENDING TITLE III TRAFFIC CODE CHAPTER 380 SCHEDULE VII AND REQUIRING ALL TRAFFIC TO YIELD AT THE INTERSECTION OF BLOOMFIELD ROAD AND THE LEVEE ROAD; PROVIDING FOR PENALTY FOR VIOLATION THEREOF AND SETTING EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF NEW MADRID, MISSOURI, AS FOLLOWS:

SECTION I: That all vehicles traveling south on Bloomfield Road shall yield to vehicles traveling east and west on the Levee Road and that no vehicle shall proceed through said intersection when another vehicle traveling on the Levee Road is present or approaching the intersection until it has come to a complete stop and all vehicles proceeding through the intersection have been allowed to go through.

SECTION II: That all persons violating the provisions of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be fined a sum of not less than one dollar (\$1.00) nor more than one hundred dollars (\$100.00) or by imprisonment for a term of not more than thirty (30) days or by both said fine and imprisonment.

SECTION III: That this Ordinance shall be in full force and effect ten (10) days after its passage and approval and all Ordinances in conflict herewith are, insofar as they conflict, hereby repealed.
